## Random matrices in Wiener chaos

We consider a random matrix whose entries are elements in a Wiener chaos of fixed order. These random entries are either independent or with a particular correlation structure. We discuss the limit behavior in distribution, under the Wasserstein distance, of its associated Wishart matrix. We use the techniques of the Malliavin calculus and the characterisation of the independence on Wiener space.
